

Registrations

A discount code to register your personnel will be provided once your vendor/sponsorship contract is processed. Any additional attendees must be registered in full online at alta.org.

All vendor, demo and sponsorship cancellations must be received in writing prior October 1 and are subject to a US \$100.00 processing fee. Refunds will be processed within 30 days after ALTA ONE 2020. Refunds will be given based on the following schedule:

- Before September 21 = a refund of 75% of total contracted price
- On or after September 21 = a refund of 50% of total contracted price
- On or After October 2 = no refund
