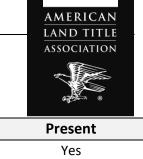

**Review of Purpose and Scope of the meeting** (Paul Martin, Co-Chairs)

Obtain a consensus on the precise wording for the expansion of the Registry Scope to include escrow companies and submit a proposal to the Board of Governors.

#### **Registry Scope Expansion Language Review**

Arising from an action item from the Committee meeting held in Austin during ALTA ONE 2019,
Committee members and ALTA Staff drafted language for a proposal to the Board of Governors for the
expansion of the Registry to include escrow companies. The draft was, through Doodle, put to a vote by
the Committee and polling closed on December 6th, 2019. The poll brought forth comments that
required further discussion to obtain a consensus the Committee could support.

#### Comments/objections:

- Policy Issuing Agents: Why ALTA is requiring a listing participant to provide real estate settlement services.
   A policy issuing agent doesn't have to provide real estate settlement services in order to issue a policy, so why would ALTA require a registry participant to perform real estate settlement services as a condition for their participation in the ALTA Registry?
- Definition: Also, from a technical standpoint, the term "personally identifiable data" is not the correct term. It should be non-public personal information.
- Commitment to protect: What evidence ALTA will require from a listing participant to confirm the participants "commitment" to protect NPI?

## • Current Scope Statement:

- The national ALTA Title & Settlement Agent Registry ("ALTA Registry") is a searchable online database of underwriter-confirmed title agent companies, real estate attorneys, and underwriter direct offices.
- After discussion the Committee agreed that the proposed language below should be used to make a
  proposal to the Board of Governors at its next meeting in February 2020.

**ALTA Registry Scope:** The national ALTA Title & Settlement Agent Registry ("ALTA Registry") is a searchable online database of underwriter-confirmed title agencies and underwriter direct offices, real estate attorneys, and real estate escrow companies.

 The proposed language was put to a voice vote, and it was accepted unanimously; ALTA Staff were directed to create a proposal and submit it to the Board of Governors for its next meeting in February 2020.
