Part 1

The ALTA Registry and its benefits?

The national ALTA Registry is a searchable online database of underwriter-confirmed title agent companies and underwriter direct offices. Also included are real estate attorneys who submit attorney licensing information as confirmation.

Why Create the ALTA Title & Settlement Agent Registry?

The Need: Identify Business Partners & Communicate with Confidence

- Regulations and technology innovation are driving vendor oversight requirements and the need for collaboration.
- Lenders, title agents, real estate attorneys, title underwriters, and other participants in the closing process must communicate in a timely and consistent manner during the mortgage transaction.
- Because there is not a unique identifier utilized across the industry for title agents or real estate attorneys, communication has often been difficult and costly for the industry and its customers.

The Missing Link: A Unique Industry ID

- After extensive discussion and careful consideration with industry partners, the American Land Title Association (ALTA) has concluded that the **ALTA Universal ID ("ALTA ID")** can provide a solution to the industry.
- ALTA offers a unique 7-digit identifier, the ALTA ID, which is automatically assigned to each new database record as a permanent ID number and is never changed, reassigned, or reused. Branch offices have their own ALTA IDs and may be connected to primary business locations with no requirement for consecutive or numerically correlated ALTA ID numbers.
- ALTA ID numbers are available for free to title agents and to real estate attorneys.

Why ALTA?

- ALTA is the national trade association for the land title insurance industry, an independent entity ideally positioned to develop this industry utility.
- More than 30,000 title agents, underwriter direct offices, and real estate attorneys already have records in the ALTA database.

How will the Registry benefit lenders?

Benefits

Unique universal ALTA ID for all title agents, underwriter direct offices, and real estate attorneys

Single source for identifying agents and attorneys, updated daily

Eliminate duplicate agent entries in internal systems

Ability to validate title agents earlier in the transaction

Records are subjected to Underwriter Confirmation

Reduced errors when placing title and closing orders

Ability to track agent status changes between order and closing

Capability for both a single manual search and data downloads

Important note, one of the factors that makes the ALTA Registry unique is the fact that title and settlement agents can only obtain a listing if their Underwriters have confirmed their details.

No underwriter confirmation = No listing in the registry

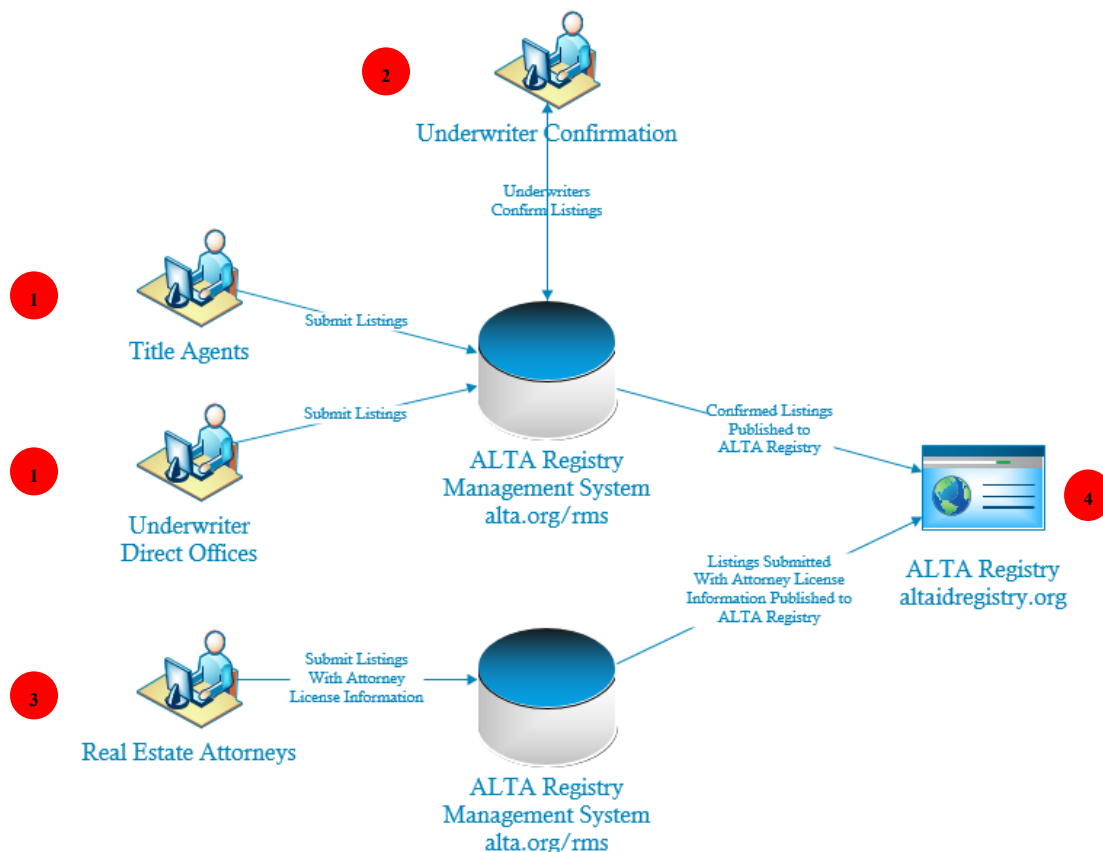

How will information be submitted, confirmed, and published in the ALTA Registry?

1. When the ALTA Registry is released, title agents, and underwriter direct offices, will be able to request an ALTA Registry listing via the ALTA Registry Management System (RMS) section of the ALTA website.
2. Underwriters will review and confirm title agent requests to be listed in the ALTA Registry.
3. Real Estate Attorneys will also be able to request a listing by submitting attorney licensing information as confirmation.
4. Confirmed listings for title agents, underwriter direct offices, and real estate attorneys will be published in the ALTA Registry and made available for search.



Who Can Search the ALTA Registry?

Any member of the public can perform a Basic search

Manual searching is available to any ALTA Registry visitor. No login is required. Basic information is displayed:

- Company ALTA ID, legal entity name, DBA name, address, phone/fax number, email address, website address, and contact information for a Registry contact person.
- Real Estate Attorney ALTA ID, name, address, phone/fax number, email address, and attorney licensing information (state and number).

How does the ALTA Registry help?

The ALTA Registry contains three important data elements which can be used to help identify a title agent. In addition, these data points help match entity records across lender, underwriter and technology vendor databases:

- **ALTA Universal ID (“ALTA ID”)** - A unique 7-digit number which may have leading zeros.
- **Legal Entity Name** - The name under which the company enters contracts and agreements and files taxes.
- **Address Validation** - Addresses will be displayed for visual validation. The ALTA Registry also shows Delivery Point Validation (“DPV”), a validation process used by the USPS to identify a location down to the unit number in a building. DPV is comprised of zip code plus 4-digit extension plus 2-digit unit plus a check digit and resolves issues with address formatting or abbreviations.
 - The ALTA Registry will provide the 2-digit unit and the check digit. This may help make address matching easier.

Q: What happens when an Agent has only 1 Underwriter and is then "Unconfirmed" by them?

A: The agent will remain in the registry for 45 days as Unconfirmed then is auto removed to archive. The agent will only reappear in the registry when another underwriter has confirmed details and business relationship.

Vendor Management Oversight Information

Vendor Management Overview		
Is registry information subject to privacy laws or other regulatory requirements?	No	There is no NPI contained in database. The registry is a platform that is free to join for the constituents and the public has access to contact and location information.
Does the ALTA Registry contain NPI?	No	Nearly all the data contained in the registry is found in the public domain – it's a sophisticated, online public phone book.
Does a lender have to supply consumer data to use the registry?	No	
Does the registry house any lender supplied data?	No	No lender information is required to search the database.
Is the ALTA ID public information?	Yes	
Is the registry online open to all?	Yes	Only lenders have access to download Underwriter information, with a subscription.
Is underwriter contact information available at a record level?	Yes	Underwriters provide their contact information for verifications etc. and these are housed centrally. Each record contains this contact information.
Are ALTA IDs reused?	No	Once an agent no longer participates in the registry their ALTA ID is retired.
Are retired records accessible?	Yes	Upon request ALTA will retrieve specific records using the ALTA ID. Additionally lenders who use the downloads will have possession of historical records in line with their own record retention policies.

Part 4

Technology and Security

HTTPS/SSL Website

- The system is deployed under HTTPS protocol and secured with SSL.
- SSL certificates create a foundation of trust by establishing a secure connection.
- SSL certificates have a pair of keys: a public and a private key. These keys work together to establish an encrypted connection.

Authentication

- Using Form Authentication: more secure and easier to manage than session authentication.
- Using timeout for session/request: return login page if user session/request reaches timeout limitation.
- Using count down time if users do not integrate with website (time is configured).

Encrypted Password

- The user's password is encrypted in database.
- The stored password in Database is generated by combination of user input, IV key and secret key.
- Using Rijinideal algorithm to encrypt/decrypt password.

Google ReCaptcha

- Using Google ReCaptcha V2 (latest version) protects ALTA Registry Website from spam and abuse.
- Using ReCaptcha in Terms and Conditions for Searching with Customer User without Account makes sure these are human actions and prevent from robot attacks.
- Using ReCaptcha in Create New User Account to prevent automatic registration by robot.
- Using ReCaptcha in Login attempt after 3 times failed.

Coding Convention

- Passed coding convention by using ReSharper tool. ReSharper helps checking coding for defect detection, the communication between components follow security standards, performance standards and making sure that components also conform to the specification requirements as well as testing for their correct functionality.
- Using Dependency Injection to communicate between system components: separate components by interfaces, source code is more secure and reduce components with unnecessary dependencies.
